QUAY TERMS - TIMBER

Our standard quay terms allow goods to remain on quay for up to FOUR weeks rent free from the date of discharge. Goods remaining on quay after FOUR weeks will attract rental charges @ GBP 0.75/M3/week or part thereof for your account. After EIGHT weeks this increases to GBP 1.25/M3/week or part thereof. In the event that goods are sold ex quay this rental liability should be transferred with the goods.

ANY CARGO EXCEEDING 3 MONTHS VIA QUAY OR SHED = GBP3.90/M3 Per Week or part thereof after the date of discharge.

ANY CARGO EXCEEDING 6 MONTHS VIA QUAY OR SHED = GBP 7.85/M3 Per Week or part thereof after the date of discharge.

SHED TERMS - TIMBER

Our standard shed terms allow goods to remain in shed for up to TWO weeks rent free from the date of discharge. Goods remaining in shed after TWO weeks will attract rental charges for your account as below.

Weeks 3 - 6 incl. GBP1.05/m3/week or part thereof, weeks 6 onwards GBP 1.75/m3/week or part thereof.

ANY CARGO EXCEEDING 3 MONTHS VIA QUAY OR SHED = GBP3.90/M3 Per Week or part thereof after the date of discharge.

ANY CARGO EXCEEDING 6 MONTHS VIA QUAY OR SHED = GBP 7.85/M3 Per Week or part thereof after the date of discharge.

SHEET MATERIALS

Our standard shed terms allow all sheet materials to remain in shed for up to FOUR weeks rent free from the date of discharge. Sheet material goods remaining in shed after FOUR weeks will attract rental charges for your account as below.

Weeks 4 - 8 incl. GBP 1.25/m3/week or part thereof, weeks 8 onwards GBP2.20/m3/week or part thereof.

ANY CARGO EXCEEDING 3 MONTHS VIA QUAY OR SHED = GBP3.90/M3 Per Week or part thereof after the date of discharge.

ANY CARGO EXCEEDING 6 MONTHS VIA QUAY OR SHED = GBP 7.85/M3 Per Week or part thereof after the date of discharge.

These rental charges apply to Hull & Immingham only and are levied for every week after the free period and charged pro rata across each B/L. In the event that goods are sold ex quay or shed this rental liability should be transferred with the goods. It is the responsibility of the seller to notify the buyer of this.
